# PRESIDENT'S REPORT

What a year 2020 has been. For our badminton community, from grassroots to the global game, we have all been impacted by the COVID-19 pandemic. In a year of ups and downs, challenges and opportunities, it has been great to see the New Zealand badminton community come together to respond in such a positive way. Through the obstacles we have encountered we have still found a way to continue the growth and development of badminton across the country. For this we thank our fantastic member Associations who stepped up to first ensure the safety of their community and then continued to deliver more and more high quality opportunities for kiwis to enjoy badminton.

I would like to make special mention of the team at Badminton New Zealand for their efforts in response to the global pandemic. We should be proud of the care, consideration and communication from Badminton New Zealand to lead the way with our COVID-19 response. Thank you to the staff of Badminton New Zealand who showed their ability to adapt and pivot to not miss a beat in delivering real value back to our badminton community.

This was greatly enhanced by our special group of stakeholders who stood beside us as we faced these challenges. It is important to recognise Sport New Zealand for the way in which they supported the sport sector and their investment into Badminton New Zealand to ensure the organisations ongoing viability. Thank you to Peter Thompson and Barfoot & Thompson, their unwavering support of our marque badminton events during a number of postponements and cancellations has been critical to our long term success. With the BWF World Junior Championships hosted by Badminton New Zealand cancelled in 2020, we thank Auckland Unlimited and the Ministry of Business, Innovation and Enterprise for their support and flexibility as we worked together to then secure the 2024 hosting rights. Badminton New Zealand has been able to move forward with confidence knowing the strength of our partnerships are behind us and supporting us all the way.

Despite a once in a generation global pandemic, Badminton New Zealand has pushed on to achieve great results for the year. Across all areas of the organisation, innovation and resilience enabled badminton to continue to go from strength to strength. This can be seen in the success of our regional development focus, the integration of the Balance is Better philosophy, the number of new Para badminton open days across the country, the collaborative community projects with multiple Associations working together, nearly 30,000 kiwi kids experiencing Shuttle Time, the exciting launch of the New Zealand Badminton League, the appointment of Trish Gubb into the semi-professional ranks of BWF umpires and the increasing achievements of our performance players to include two Oceania Championship titles.

Finally, I would like to thank my fellow Board Members of Badminton New Zealand. This year hasn't been easy, but through the commitment and collective wisdom of our governance team we have ensured Badminton New Zealand remains a strong and vibrant organisation. Special thanks to

Stephen Nelson who ended his term on the Board in early 2020. Stephen did so much for Badminton New Zealand behind the scenes and his ability to think deeply and innovatively was a huge asset to the organisation. Board Chair Hetty Van Hale also stepped down at the conclusion of 2020 and her leadership and insight will be missed. Hetty enabled and empowered the Board to raise its game and become more professional in key governance areas. Thank you Hetty for the positive impact you have had on Badminton New Zealand. With a mix of new and experienced Board Members combined with a great team of staff, stakeholders and Associations, Badminton New Zealand is well placed to continue making a huge difference in inspiring Kiwis to love badminton for life.



### CHAIR'S REPORT HETTY VAN HALE

#### Tēnā koutou katoa,

Badminton New Zealand can be proud of it's achievements through a challenging 2020. Despite a global pandemic and an operating environment that included a number of uncertainties, our organisation has maintained it's ability to add value and positively impact the New Zealand badminton community. More than 29,000 kiwi kids participated in our Shuttle Time school badminton programme offering more than 154,000 opportunities to experience badminton. Two metro community projects in partnership with Associations and RSTs saw more than 50 coaches trained to support 14 new programmes. Adapting to the changing environment, 86 coaches access online coaching forums and workshops to understand how to adjust to COVID-19 precautions. Continued success in the regional approach saw 23 coaches and 69 players access important technical and tactical development. We are proud that Badminton NZ managed to undertake the only tertiary sports event for the year in partnership with UTSNZ and the record number of entries for our New Zealand Masters National Championship event hosted by Badminton Waitakere. Our performance players continue to improve and this was seen at the last international event, the Oceania Championships, with improved results across the board including two Oceania Titles.

Work to achieve the Governance Mark continued in 2020 as part of our ongoing commitment to organisational excellence. However, progress was slowed by COVID-19 as the Board had to shift its primary focus to financial sustainability and the health, safety & wellbeing of our staff. We expect to achieve the Governance Mark by mid-2021.

During the year considerable work was undertaken by the staff on implementing the new strategic plan to 2024, but again some elements had to be delayed owing to the pandemic.

Badminton New Zealand could not achieve its goals alone and the organisation is committed to strong partnerships and collaboration. In this regard I would like to acknowledge the invaluable support we receive from the team at Sport New Zealand. Thanks also to all our key partners – the 25 badminton Associations, Barfoot & Thompson, New Zealand Major Events, YONEX, ATEED, the New Zealand Olympic Committee, Paralympics New Zealand, Badminton Oceania, the Badminton World Federation, Massey University and all our amazing event partners.

On behalf of the Board I would like to thank and acknowledge CEO Joe Hitchcock and his outstanding team for their handling of communications during and post the COVID-19 lockdown. In an uncertain environment, and while working from home, their professional approach to keeping all stakeholders updated was truly best practice. The board and staff continue to have an excellent relationship with mutual respect and trust.

Improved financial reporting and policies, including improved cashflow forecasts, was a focus

this year and we now have more robust reporting systems in place. Again, we are grateful for the capability support we received from Sport New Zealand in this area.

During 2020, as part of Board succession planning, the Board piloted a Board Intern programme and Susannah Leydon-Davis was appointed as the Board Intern for the year, in parallel with her role as Athlete Representative. The Board would like to thank Susannah for her contribution and in particular her insights into the High Performance player environment. Simon Lin has been appointed as Board Intern for 2021. The intern programme provides an opportunity for us to provide governance development support, enhance Board diversity and grow the pool of young people to become future directors.

I would also like to thank President Ian Willans and our dedicated Board for their time and extra commitment, during a trying year. At the 2020 AGM, Stephen Nelson retired from the Board and I would like to acknowledge the significant contribution Stephen made during his 4 years on the Board. Stephen's business acumen along with his strong knowledge of and connections in the badminton community will be hugely missed. Christina Yu was appointed to the Board to replace Stephen, and Christina brings a strong mix of business skills, diversity and excellent business links into the Chinese community.

This is my last report as Chair as I stepped down from the Board at the end of December 2020. But I believe I am leaving the organisation in good heart and welcome new Chair John Moody to the role. Badminton New Zealand has a diverse and knowledgeable governance team and coupled with a strong organisational culture, and skilled and dedicated staff, badminton in this country has a great future.



### CHIEF EXECUTIVE'S REPORT

#### **JOE HITCHCOCK**

The true test of any organisation is how it responds in tough and challenging times. 2020 was a year that tested us all, creating a number of obstacles we have not experienced in our lifetimes. I could not be prouder of how Badminton New Zealand has navigated through the unknown to successfully complete the year and achieve so much with and for our badminton community. From participation to performance, even a global pandemic has not been able to stop the growth of our game as badminton continues to boom around New Zealand. The foundation for this ability to flex, innovate and achieve in adversity is our strong governance and organisational culture, the partnerships across stakeholders that support badminton, and most importantly the passionate people that care deeply about inspiring Kiwis to love badminton for life.

As a team we have worked hard to ensure minimal disruption through a chaotic year of lock-downs, Zoom meetings, alert levels, and a lot of hand sanitiser. It has not been easy and the roller-coaster of emotions of starting, stopping, postponing, rescheduling and cancelling has taken a toll on all of us in the badminton community. But every obstacle has an opportunity and I have been blown away by the ability to adapt from our team as well as the wider badminton community. It has been exciting to see new initiatives emerge alongside a commitment to continue the important work that grows and develops badminton across New Zealand. Reading through the different programme area summaries in this report is immensely satisfying and reflects the tremendous contribution our team at Badminton New Zealand made in 2020.

I will always remember the first opportunity to get back on court to deliver the first round of the New Zealand Badminton League following the lifting of COVID-19 restrictions in June. I don't remember who played, who won or whether it was a good match. I only remember the pure joy of our badminton community coming back together to talk, to laugh, to banter and reconnect back together through something that they are passionate about. It is a great reminder of why we do what we do. For the first time in many years the Barfoot & Thompson NZ Badminton Open was cancelled as well as the 2020 BWF World Junior Badminton Championships. Through the support from Barfoot & Thompson, New Zealand Major Events, Auckland Unlimited and the BWF, we were fortunate to secure the same hosting rights to 2024. We are excited by the opportunity to host this major international event and then a year later host the BWF World Senior Championships in 2025.

With so much churn and uncertainty, we re-phased our new strategic plan and this provided a useful road map that ultimately led to the achievement of a number of key initiatives. A real highlight was the design, development and delivery of the inaugural New Zealand Badminton League. An opportunity forged in adversity, it has provided us the chance to put all our crazy ideas into one concept. Changing the scoring format, including time-outs and Golden Games, creating our own broadcast and production unit, having franchise teams and delivering seven weeks of badminton action, showed what we are capable of achieving when we have the courage to try radical new

things. It was wonderful to provide a performance opportunity to our top players, coaches and technical officials when no international badminton was available. The future is bright for the league with amazing feedback from season one. Our players are stepping into the spotlight and fans are loving the fast paced and exciting nature of the format. This could not be achieved without the solid base built through our community and development teams, that ensure we have the nuts and bolts of a system that allows badminton to thrive at all levels.

After a difficult year, there is a huge number of people and organisations to thank. Although the list is too long to include everyone that contributes to the success of badminton in New Zealand, I did want to make special mention of a few. Thank you first and foremost to our President Ian Willans, who works tirelessly behind the scenes to support badminton from grassroots to High Performance. Ian has been a pillar of strength for the organisation and staff, and we are incredibly fortunate to have him as our President. To Hetty Van Hale and the Board of Badminton New Zealand, who never wavered in their commitment to looking after our sport and also our team. To Sport New Zealand, who really stepped up in our time of need to provide support, advice and investment that enabled the viability of the organisation to continue. To Peter Thompson and Barfoot & Thompson, who showed the true meaning of partnership as they stuck with us and believed in badminton while we worked through a number of challenges. And the Badminton Waitakere family, led by Peter Beckerleg and Paul Shirley, opened their doors for us and enabled the New Zealand Badminton League to take place through their generous and ongoing support. We are incredibly fortunate that all our Associations, sponsors, stakeholders and funders rallied around us to ensure we could continue to add value and contribute to the badminton community.

Finally, it is critical to recognise our incredible team at Badminton New Zealand. Brent Miller, Colleen Van de Laar, Donna Trow, Jonathon Stone, Michelle Au, Rikke Olsen Siegemund and Sam Paterson are not only extremely effective in each of their roles that inspire Kiwis to love badminton for life, but they are amazing people. They genuinely care and give everything they have to make a positive difference through badminton. Combine this with our fantastic volunteers and supportive badminton community and we are truly fortunate and have the ability to ensure an enduring legacy for badminton in New Zealand.



# DEVELOPMENT

#### **DONNA TROW**

#### **COACH EDUCATION BWF LEVEL 1:**

The globally recognised BWF Level 1 Coach Education Course is Badminton New Zealand's platform to develop identified Association coaches to deliver quality coaching experiences for players.

In 2020 two BWF Level 1 Courses were delivered over two weekends in Christchurch and Auckland. Due to COVID-19 disruptions we found that many participants were unable to complete the course and will look to do so in 2021. However, there were 20 participants who undertook both weekends of the BWF Level 1 Course in 2020 and of those, 17 people achieved the Level 1 gualification.

Thank you to our New Zealand BWF Level 1 Tutors – Chris Bright, Ritchie Marr, and Brent Miller for their quality delivery and to Badminton Oceania for their support throughout the courses.

#### **REGIONAL COACH & PLAYER DEVELOPMENT CAMPS:**

The Regional Coach & Player Development Camps delivered in 2020 have had a significant impact towards increasing the number, scope and capability of people involved in coach and player development programmes throughout New Zealand.

We have seen several new coaches and players being introduced to Badminton New Zealand's Development Programme themes and concepts. We believe that the coaches and players now have a clear understanding of what we are trying to achieve with our development programmes and how we are delivering them. The Central and Mainland Region continue to develop regular coach & player development programmes within their regions.

As we continually try to evolve and grow the capability of our regional coaches and players, we need to create further opportunities. As a result, 2020 saw the introduction of the Combined Camp. This is where the top tier coaches and players from the Central and Mainland Region came together to attend a camp delivered by Badminton New Zealand's Performance Manager, Rikke Olsen Siegemund and Badminton New Zealand's Lead U15 Development Coach, Brent Miller.

Following on from the success of these regional camps Badminton New Zealand has begun to deliver selection camps for the NZ U15 Development Squad within the regions ensuring players have an opportunity to access selection opportunities.

#### **ONLINE COACHING FORUMS:**

2020 proved to be a difficult year and like many other organisations Badminton New Zealand was required to think about how we continue to provide opportunities to our stakeholders in the current climate. Therefore, the creation and delivery of Badminton New Zealand's Online Coaching Forums transpired. Due to the popular uptake of these forums Badminton New Zealand will continue to offer these opportunities in 2021.

#### **BALANCE IS BETTER:**

In 2020 Badminton New Zealand signed on with Sport New Zealand as a Balance is Better code. Balance is Better has been developed by Sport New Zealand to inform and provide a framework that puts the need of the participants first. Balance is Better is an evidence-based philosophy that underpins Badminton New Zealand's overall approach to development.

The Balance is Better philosophy pushes back against these myths to stress that:

- Childhood success is not a reliable predictor of future success.
- Identifying athletes early and specialising early is taking its toll on young people.
- A focus on winning rather than development is a problem for young people, because it can have unintended consequences on their well-being and affect their motivation to take part.

In 2020 Badminton New Zealand carried out the following Balance is Better initiatives:

• Signed on with Sport New Zealand as a Balance is Better Code - March 2020

- Appointed a Balance is Better Ambassador; Oliver Leydon-Davis July 2020
- July 2020
- Championship tournament participants are able to play one age-group up only.

For Badminton New Zealand, Balance is Better is about developing the badminton system to better prepare players in their development phase to reach their potential not only as a player but as a person.



### COMMUNITY **BRENT MILLER**

Through the challenging year of 2020 Badminton New Zealand's focus in the community space was to ensure all Associations kept their doors open and to provide support wherever needed. 2020 saw support go to areas such as player and coach development, Governance and Board support, Strategic Planning facilitation and support, Association collaboration and funding.

A continued focus was placed on sustainable growth within Associations through partnering in building capability in the workforce. This saw 2 National Tutor courses held in Wellington with 7 new tutors trained and able to train workforce locally. We also saw 127 new coaches trained either as a Shuttle Time Teacher or Student Youth Leader.

#### Major projects saw the following:

Completion of the Aktive KiwiSport Project in partnership with Auckland Badminton, Badminton North Harbour, Badminton Waitakere and Counties Manukau Badminton.

- 33 Students and 17 adults trained bringing 50 new Shuttle Time coaches to the region.
- An additional 50 Student Youth Leaders that have started their training but were unable to complete due to Covid-19.
- Over 1100 Air Badminton shuttles delivered to students across the Auckland Region.

#### Completion of a wider Wellington Region KiwiSport project in partnership with Wellington Badminton, Wellington North Badminton and Badminton Hutt Valley

- 14 new programmes with 417 participants
- Over 2500 opportunities
- 6 events delivering to 196 participants.
- A co-design resource developed and implemented.

Facilitation of a wider Wellington "Capital Strategy" where the local associations have decided to collectively focus on the following four areas to be rolled out in 2021:

- Shuttle Time
- Events
- Marketing
- Reducing Barriers to participation



Overall, the Shuttle Time numbers were approximately 25% down on 2019, which was to be expected, with lockdowns consuming most of the season, and limiting the numbers that were able to attend.

On the positive side, Associations coped well to adjust and deliver the programmes they did in the period available and should be proud of the numbers they achieved after the challenges everyone faced.



Fresh after the lifting of New Zealand's lockdown, the badminton community rose to deliver the first NZBL season, providing New Zealand players with an opportunity to compete at their peak once more. The NZBL trialled many exciting innovations including a 3 to 11 scoring format, coaches' time-out, Golden Game, and MVP award. Partnering with Sky Sport, the event was televised in prime-time slots to households across the country over seven exciting weeks.

Working closely with University and Tertiary Sport New Zealand, Badminton New Zealand delivered the only National Tertiary Championships of 2021. The event proved to be the highest quality yet, with New Zealand National Squad players filling many of the seven teams. In a tense final, University of Auckland overcame Massey University to regain the Robson Shield.

The New Zealand Masters National Championships proved successful with the largest ever entries in the history of the competition, while the Junior Championships provided an opportunity for players to close the year spending quality time with friends.

Looking to 2021, the Badminton New Zealand Events Team are excited to turn their attention to a year of comebacks, including the return of the New Zealand Junior Team Championships and New Zealand Secondary School Championships.

We would like to offer a tremendous thank you to our Associations for the mahi put in throughout the season to ensure that our community received as many quality experiences as possible. Finally, we would like to recognise the support of our Technical Officials, volunteers, funders and supporters – your continued support is always appreciated, and we hope you are as excited as we are for an outstanding 2021.



### **TECHNICAL OFFICIALS** SIMON LIN

The disruptions caused by COVID-19 have equally impacted our Technical Officials for the 2020 season. Restrictions saw tournaments being postponed or cancelled, resulting in limited opportunities for our T.O's to be involved. However, despite COVID-19, we saw the inauguration of the New Zealand Badminton League, which not only provided opportunities to our elite players, but also to our referees, umpires and line judges to get involved and keep their skills current.

The Committee continued to commit time and resources to provide training to grow our pool of Technical Officials. I am particularly proud of the effort the team has put in to formalise the pathway for our line judges, a hugely important role as part of the Technical Official family. We are now recognising many of our long serving line judges with a National Accreditation. Although the impacts of COVID-19 have alleviated our referee capacity issue for the 2020 season, this continues to be a challenge, and will be a focus again for the committee in 2021.

Finally, congratulations to Trish Gubb who has been appointed as a semi-professional Umpire by Badminton World Federation, another great step forward in recognising the professional services provided by Technical Officials worldwide.

### PERFORMANCE **RIKKE OLSEN SIEGEMUND**

It has been a very challenging 2020 for our Badminton New Zealand Performance Programme with the worldwide arrival of COVID-19 and the impact it has had on our training periods here in New Zealand, and even more importantly, the impact it has had on our tournament plan with continuous postponements or cancellations of tournaments, not to mention all the uncertainty we have been dealing with as a group.

There have been a few changes during the year in our NZNS/NZDS Squads, meaning we have let go of a couple of players and we have welcomed a handful of new players, most of which have come from our Junior Performance Programme. Currently we have fifteen players in the New Zealand Development Squad (NZDS) and New Zealand National Squad (NZNS) and we also have five players on trial for a period of six months. We are running five weekly trainings, mostly out of our training base at Massey University in Albany, and we have cut down Saturday morning trainings for now due to the economic situation and the fact that we still need to improve our Strength & Conditioning - this way the players get more free time to prioritise their gym and/or cardio training.

We have for the last year and a half, been inviting some of our New Zealand U19 players to join the NZNS and NZDS trainings and it is pleasing to see that these players are fully adapted and now are a part of our weekly sessions. We have created a pathway for our best New Zealand U19 Squad Members moving out of our Junior Performance Programme, meaning that the best of them get an opportunity to join the NZDS and NZNS trainings for a trial period of six months. This transition period has been a real success with more and more young players committing and understanding the performance pathway.

Our original plan was to get a bigger group of players to compete in overseas tournaments, so we could start to build a ranking for them towards Commonwealth Games 2022 and to get them exposed to different environments and player styles, which is an important part of their next learning step, but due to the COVID-19 situation across the world this has not happened yet.

At the beginning of this year we had a lot of focus on Strength & Conditioning (GYM) and we took time out in trainings to optimize on this area. It has improved a lot and most players are really confident at the gym and my focus has shifted to the cardio part, so for the past five months I have included one of our two weekly cardio sessions in our Friday morning session to ensure all are doing cardio at a high intensity and as well to use the group energy so the players can support and push each other, which so far has worked really well.

COVID-19 has taught us that there are more ways to do different things and one of them is Zoom meetings, which we as a group have used often during the lockdowns. All players have had ongoing individual meetings in person or on Zoom, where we evaluate the last period and discuss how it went and if we want to change anything for the next period. Unfortunately, the Oceania Championships was the players' only international tournament for the year and then we used the New Zealand Badminton League as a smaller peak. We did not have time enough to build a full training cycle around the league due to lockdown, but it worked out okay in the end. In these meetings we discuss their weekly plans, tournament plan, their SMART (development goals), their short and long-term goals and what they must be aware of to reach them.

Since November 2019, we have had Tony Griffen on our coaching team, which gives us an opportunity on Thursday mornings to split the bigger group of players into two smaller groups, where Tony has been working with the singles players and I have been working with the doubles players. All other sessions are run by me, where I still prepare plans with a doubles and a singles focus. With Tony at training, we are able to give more attention to each player, which is an important part in their development. The setup around the NZDS/NZNS players is now at such a good quality, that we need to look for the next step in its development, so we can continue to maintain, shape, and keep the setup as strong as possible.

I personally believe that the next two important steps in our development on our way towards the international stage are to get the players overseas to compete and to start to work more intensely with their game plans, which include video analysis.

- To compete overseas will get them a ranking and help them to get an understanding of where they are at and what they need to be better at.
- The video analysis will help their understanding of their own habits (strong/weak sides) and in singles, how a player wins most of their rallies or something totally different.

The Badminton New Zealand National Squad achieved the following results in 2020:



#### Notes to the Financial Statements

Badminton New Zealand Incorporated For the year ended 31 December 2020

#### 1. Reporting Entity

New Zealand Badminton Federation Incisincorporated under the Incorporated Societies Act 1908 and is subject to the provisions of the Act. The financial statements are a special purpose report which has been prepared in accordance with the accounting policies below.

These financial statements have not been prepared for external use. They are prepared for governance purposes only and should not be relied on for any other purpose.

The comparative figures provided in the financial statements are for the year ended 31 December 2019.

2. Statement of Accounting Policies

The following accounting policies which materially affect the measurement of financial performance and financial position have been applied:

#### Measurement Base

These financial statements have been prepared on a historical cost basis.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

Revenue Recognition

Revenue is recognised on an accrual basis.

Grants (including Sport New Zealand) and sponsorship are recognised when the conditions attached to the grants have been met, and have been utilised in accordance with these conditions. Until any such obligations have been met, any grants or sponsorship received in cash are shown as income in advance.

Membership Levies are recorded in the year to which they relate.

Entry Fees (including New Zealand Open) and Player Contributions are recorded in the year to which they relate.

Goods and Services received in kind are not recorded as revenue.

#### Accounts Receivable

Accounts receivable are stated at expected realisable value.

Inventories

Inventories are stated at the lower of cost, determined on a first-in-first-out basis, and net realisable value.

#### **Fixed Assets**

Fixed assets are stated at historical cost less any accumulated depreciation and impairment losses.

An item of fixed assets is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the year the asset is derecognised.

#### Depreciation

#### To the Members of Badminton New Zealand Incorporated

#### Opinion

We have audited the special purpose financial statements of Badminton New Zealand Incorporated (the Society) on pages 4 to 10, which comprise the balance sheet as at 31 December 2020, the statement of profit or loss and statement of movements in equity for the year ended 31 December 2020 and notes to the special purpose financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying special purpose financial statements present fairly, in all material respects, the financial position of the Society as at 31 December 2020, and its financial performance for the year then ended in accordance with the accounting policies as disclosed in Note 2 of the special purpose financial statements.

#### **Basis for Opinion**

#### **THE BOARD'S FOCUS**

The Board's focus is on setting strategy, monitoring and measuring progress towards the organisation's strategic goals, identifying and mitigating risks that face the organisation, developing and reviewing policy, monitoring health & safety, and guiding the performance of the Chief Executive. In 2020, there was also an extra strong strong focus on the health, safety, and wellbeing of the staff both during and post the COVID-19 lockdown.

The Board work plan in 2020 included:

- · Increased number of meetings by Zoom during the year post lockdown to monitor the financial health of the organisation
- Monitoring the implementation of the new strategic plan for to 2024
- Continued progress towards achieving the Governance Mark
- Review of the Board Charter •
- Development and adoption of new policies, and review of existing policy
- New cash flow forecast reporting formats
- Board succession planning to transition to a new Chair for 2021
- Piloting the board intern programme.

#### **BOARD COMPOSITION**

The Board is comprised of four elected members (one of whom is the President) and three appointed members. There was one new Board member in 2020 when Christina Yu was appointed to replace outgoing Board member Stephen Nelson. Existing Board member, Danny Chan, was also reappointed for a further three year term.

#### COST OF GOVERNANCE

Board related costs for 2020 were \$8,201 compared with \$12,213 in 2019 (predominantly for airfares and accommodation). Board costs in 2020 were lower than the previous year owing to the reduced number of face-to-face meetings as a result of COVID-19.


