## Regulations

### 2022 Waitakere U17 Open 5<sup>th</sup>-6<sup>th</sup> of March - Conditions of Entry and Play

#### GENERAL

1. It is expected that players will have read, and are familiar with the "Conditions of Entry and Play" prior to submitting an entry
2. Players entering must be a member of, and in good standing, with an Association affiliated with Badminton New Zealand or the Badminton World Federation.
3. The rules of play shall be those of the Badminton World Federation with the use of the Alternative Service Law 9.1.6. a of the service rule which shall be as follows.
  - a. The whole shuttle shall be below the server's waist at the instant of being hit by the server's racket. The waist shall be considered to be an imaginary line round the body, level with the lowest part of the server's bottom rib;
  - b. The shaft and the racket head of the server's racket at the instant of hitting the shuttle shall be pointing in a downward direction'.
4. This is a tier 12 Tournament. (relates to your player points).
5. The scoring system to be used shall be as per the current BWF regulations.
6. All questions as to rules shall be resolved by an appointed tournament official.
7. Approved feather shuttles will be used.
8. The tournament will be seeded using the BNZ U17 National Rankings list as at the close of entries.
9. The draw and schedule will be available on the Badminton New Zealand website on **Wednesday 2<sup>nd</sup> March 2022** prior to the tournament.
10. The Tournament Committee and/or Referee reserves the right to:
  - a) Cancel any event in which insufficient entries are received, or if time does not permit a full competition to be played.
  - b) Change the scoring of or format of plate events if time constraints require.
  - c) Default a player who is not available to play at the scheduled time.

#### PLAYER REQUIREMENTS

11. Players entering the Under 17 age group in 2022 will be born in **2006-2011**.
12. Competitors must obtain permission to leave the hall.
13. Players will be defaulted if they are not on court ready to play within 2 minutes of being called.
14. Players must wear regulation badminton clothing as per the BNZ Approved Clothing regulations. Tracksuits, jerseys etc must be removed before the start of a match. Non-marking footwear is to be worn.
15. All players must act as umpires or line judges when requested. Failure to do so may result in the player being defaulted.

16. Players compete at their own risk. No responsibility will be accepted for any injury received during the tournament.
17. Following one warning for misconduct, the appointed tournament official shall have the authority to disqualify a player from further play if there is a repeat of misconduct.

#### ENTRY DETAILS

18. Entry can only be made online and must be received with cleared full payment no later than 23:59 **Friday 25<sup>th</sup> February 2022**. On-line entry is available under the Events section at the Badminton New Zealand website – [www.badminton.org.nz](http://www.badminton.org.nz)
19. Entries for Doubles and Mixed Doubles will not be confirmed unless entries, with full payment, are received from both partners by the closing time/date. This excludes 'partner required' entries. It is not the responsibility of Badminton Waitakere to follow up for entries from nominated, but un-entered partners.
20. Players withdrawing after entries have closed will not be eligible for a refund unless a medical certificate is submitted at the time of withdrawal. No player will be eligible for a refund after 8am on the first day of the tournament. Players who withdraw from one event are still eligible to play in the other remaining events.
21. There will be no replacements in Singles events.
22. Replacements in Doubles and Mixed Doubles events after the draw is published may be allowed only with the approval of the tournament director or referee; in line with BWF competition regulations. Replacement players can only be sought from players already entered in the tournament.
23. The format for this tournament will be a round robin followed by a knock-out for the winners and runners up of the boxes. Those not progressing to the championship round will enter a Plate Competition which will be round robin for Singles and knock out for doubles and mixed. Entry is automatic for plate qualifiers. Players wishing to withdraw must advise the Tournament Controller immediately after their first match loss. If a player defaults, withdraws or retires (does not complete) their first match, they are not eligible for the plate.
24. A \$10 administration fee will be deducted from all refunds
25. A BNZ compulsory Player Levy of \$12.00 is payable by all competitors.

#### ENTRY FEE PAYMENT

26. In addition to the player levy of \$12, entry fees are \$30 each event per person for singles & Doubles and \$25 for Mixed Doubles. Fees can be paid by Direct Credit or Internet Banking to "NZBA" account# 06 0193 045 1712 01. Therefore all 3 events will cost \$97. Please enter Particulars as WTK U17 and Reference as the player's name. Please Note: the name of the player's parent or the bank account name does not identify the

- player. If your system does not allow entry of alpha characters please use your BNZ player number.
27. You should allow at least two working days for the entry fee payment to be processed through the banking system.
  28. ## BNZ/Waitakere Badminton Covid Response Plan

### COVID-19

- 1.1. Proof of vaccination (My Vaccine Pass) will be required for all participants aged over 12 years and 3 months. Please email a copy in with your entry.
- 1.2. Badminton New Zealand and Badminton Waitakere will follow the COVID-19 requirements as advised by the New Zealand Government, Ministry of Health and Sport New Zealand throughout this tournament. Such requirements may include, but

are not limited to: contact tracing, physical distancing, face coverings and personal hygiene.

- 1.3. Badminton Waitakere reserves the rights to suspend, postpone or cancel the tournament in line with these requirements.
- 1.4. Badminton Waitakere will allow players to withdraw from the tournament at any point up until their first match of the tournament due to concerns regarding COVID-19 by notifying the Tournament Controller or the referee of their withdrawal as per regulation 20. A player utilising this clause to withdraw will receive a full refund and will be withdrawn from all events.
- 1.5. If a player returns a positive test result for COVID-19 after the close of entries, this player shall be withdrawn from the tournament unless subsequently cleared by a medical professional. The player shall be entitled to a full refund of entry fees, and their partners shall receive a refund for the affected events if a suitable substitute is not available.
- 1.6. Badminton Waitakere will provide players with a full refund of their entry fee if the tournament is suspended, postponed or cancelled, however will not consider financial reimbursement of any other costs related to the tournament.
- 1.7. Badminton Waitakere reserves the rights to disqualify any player from the tournament who are deemed to have disregarded any reasonable instruction related to the Badminton New Zealand/Badminton Waitakere COVID-19 response.
