Conditions of Entry

- 1. Any player entering must be a member of, and in good standing with an association affiliated to Badminton New Zealand or the Badminton World Federation
- 2. The Rules of play shall be those of the BWF. The Referee or Tournament Controller shall decide all questions regarding Rules of the game.
- 3. This event will be played as a knockout, unless the number of entries dictates that it be played as a round robin. The decision to play round robin matches is at the discretion of the Tournament Controllers. Pease note: A doubles or mixed doubles entry is not confirmed until an entry and entry fees are paid by the due date, by both players (this excludes "partner required" entries). Replacements in doubles and mixed doubles events after the draw is published may be allowed only with the approval of the Tournament Controller or Referee. Replacement players can only be sought from players already entered in the Tournament.
- 4. Scoring to be as per the current BWF regulations.
- 5. This event will be played using the Alternative Service Law 9.1.6.
 - a. The whole shuttle shall be below the server's waist at the instant of being hit by the server' racket. The waist shall be considered to be an imaginary line round the body, level with the lowest part of the server's bottom rib;
 - b. The shaft and the racket head of the server's racket at the instant of hitting the shuttle shall be pointing in a downward direction.
- 6. The seeding will be based on the National Rankings in the Under 13 category as the close of entries.
- 7. Competitors must act as Umpires and Linesmen when called upon to do so.
- 8. Feather shuttles will be used in all events
- 9. The Tournament committee reserves the right to:
 - a. Amend the hours of play
 - b. Cancel any event for which there are less than 8 entries
 - c. Default any players not present when called for.
- 10. All players must wear regulation badminton attire as per the BNZ Approved Clothing Regulations. Non-marking shoes must be worn.
- 12. Play will commence at 9am on Saturday and 9am on Sunday
- 13. Players for the event must be born in or after 2010.
- 14. A plate will be held in all events, except those which have been played as a round robin. Plate entry is automatic for the losers of their first match in all knock out events. Players wishing to withdraw must advise the tournament controller immediately after their first match loss. If a player defaults, withdraws or retires (does not complete) their first match, they are not eligible for the plate. Every effort will be made to give every player 3 matches.
- 15. All players enter at their own risk. No responsibility will be accepted for any injury suffered during the tournament.

- 17. Players withdrawing after entries have closed will only receive a refund of the entry fee, less the administration fee of \$10, on submission of a medical certificate at the time of withdrawing. No refunds will be made for withdrawals received after the tournament has commenced. Players may withdraw from individual events without being required to withdraw from all events.
- 18. Players are NOT permitted on the courts between matches unless they are warming up for the next scheduled match on that court.

All players must report to the Tournament Controller on arrival and before leaving the Hall for any reason prior to the end of the day's play
