SANCTIONED EVENT

**Conditions of Entry** 

- 1. Any player entering must be a member of, and in good standing with an association affiliated to Badminton New Zealand or the Badminton World Federation
- 2. The Rules of play shall be those of the BWF. The Referee or Tournament Controller shall decide all questions regarding Rules of the game.
- 3. This event will be played as a knockout, unless the number of entries dictates that it be played as a round robin. The decision to play round robin matches is at the discretion of the Tournament Controllers.
- 4. A doubles or mixed doubles entry is not confirmed until an entry and entry fees are paid by the due date, by both players (this excludes "partner required" entries).
- 5. Replacements in doubles and mixed doubles events after the draw is published may be allowed only with the approval of the Tournament Controller or Referee. Replacement players can only be sought from players already entered in the Tournament.
- 6. Substitution is only allowed in the doubles events from players already entered in the tournament and must be approved by the Referee.
  - a. Only one Player in each Pair in the draw can be substituted.
  - b. If two players from two different pairs in the same Event are put together, the placement of the new pair shall be at the position of the pair seeded in the highest seeding group.
  - c. If none of the pairs are seeded, or seeded in the same seeding group, the position shall be drawn by lot between positions of the two original pairs.
- 7. Scoring to be as per the current BWF regulations.
- 8. This event will be played using the Alternative Service Law 9.1.6.
  - a. The whole shuttle shall be below the server's waist at the instant of being hit by the server' racket. The waist shall be considered to be an imaginary line round the body, level with the lowest part of the server's bottom rib;
  - b. The shaft and the racket head of the server's racket at the instant of hitting the shuttle shall be pointing in a downward direction.
- 9. The seeding will be based on the National Rankings in the Under 13 category as the close of entries being 14<sup>th</sup> April 2023.
- 10. The draw and schedule will be published by 11:59 pm Wednesday, 19th April 2023 on tournament software.
- 11. Competitors must act as Umpires and Linesmen when called upon to do so.
- 12. Feather shuttles will be used in all events
- 13. The Tournament committee reserves the right to:
  - a. Amend the hours of play
  - b. Cancel any event due to Covid-19 related restrictions, insufficient entries, or if time does not permit a full competition to be played.
  - c. Change the scoring of plate events if time constraints require.
  - d. Default any players not present when called for.
- 14. All players must wear regulation badminton attire as per the BNZ Approved Clothing Regulations. Non-marking shoes must be worn.





- 15. Play will commence at 9am on Saturday and 9am on Sunday
- 16. Players for the event must be born in 2011, 2012 or 2013.
- 17. A plate will be held in all events, except those which have been played as a round robin. Plate entry is automatic for the losers of their first match in all knock out events. Players wishing to withdraw must advise the tournament controller immediately after their first match loss. If a player defaults, withdraws or retires (does not complete) their first match, they are not eligible for the plate. Every effort will be made to give every player 3 matches.
- 18. All players enter at their own risk. No responsibility will be accepted for any injury suffered during the tournament.
- 19. On line entries are available on Badminton New Zealand website (<a href="www.badminton.org.nz">www.badminton.org.nz</a>).

- 20. Players withdrawing after entries have closed will only receive a refund of the entry fee, less the administration fee of \$10, on submission of a medical certificate at the time of withdrawing. No refunds will be made for withdrawals received after the tournament has commenced. Players may withdraw from individual events without being required to withdraw from all events.
- 21. Players are NOT permitted on the courts between matches unless they are warming up for the next scheduled match on that court.

All players must report to the Tournament Controller on arrival and before leaving the Hall for any reason prior to the end of the day's play
