CONDITIONS OF ENTRY

All players submitting entries for the tournament will be deemed to have read and accepted the conditions under which the tournament events are to be conducted.

RULES AND REGULATIONS

1. Players entering must be a member of and in good standing with an Association affiliated with Badminton New Zealand.
2. Players must be a New Zealand Player which is defined as "a person who holds any of the following: A New Zealand Passport, Citizenship or Residency. In the case of Residency, a player must have resided continuously in New Zealand for a minimum of one year." Badminton New Zealand may request documentation to confirm this status.
3. Players who have been granted eligibility by Badminton New Zealand to play in a New Zealand Inter-Association team as a New Zealand player are also eligible to compete in the competition.
4. All players must meet the following age requirements to be eligible to compete in the respective age group:
 - 4.1. Players who turn 13, 14, 15, 16 in the year of competition
5. The tournament will be conducted in accordance with the Laws of Badminton adopted by the Badminton World Federation (BWF). This event will be played using the Alternative Service Law 9.1.6.
 - 5.1. The whole shuttle shall be below the server's waist at the instant of being hit by the server's racquet. The waist shall be considered to be an imaginary line round the body, level with the lowest part of the server's bottom rib.
 - 5.2. The shaft and the racquet head of the server's racquet at the instant of hitting the shuttle shall be pointing in a downward direction.
6. Players will be required to umpire or line judge at the discretion of the Referee or Event Director. There is an Umpire of the Championships to be determined by the Referee.
7. All players must wear regulation badminton attire as per [Badminton New Zealand Approved Clothing Regulations](#). The clothing code applies to this tournament and a fine of \$30 (including GST) will be fined to players for each violation, as reported by the event referee.

- 7.1. Doubles partners are encouraged to wear the same colour clothing.
- 7.2. Non-marking shoes must be worn.
- 7.3. A player who wears a shirt that displays a name, club, association, or country must display their own name and the club, association, or country they represent. Playing shirts displaying a country other than New Zealand are not permissible.
- 7.4. Event shirts produced and sold by Badminton New Zealand are permitted to be worn.
8. YONEX AS20 Shuttles will be used.
9. All Championship matches shall be the best of 3 games to 21 points with extension.
10. Division 2 and 3 will be offered in all events, subject to minimum entries of 8.
 - 10.1. Players who do not win their first Championship match will progress to Division 3.
 - 10.2. Players who do not win their second Championship match will progress to Division 2.
 - 10.3. The draw and scoring format for Division 2 and Division 3 matches will be decided at the discretion of Badminton New Zealand. If a player defaults, withdraws, or retires (does not complete) in any championship match, they are not eligible for Division 2 or Division 3 in that event.
11. The Referee's decision on all questions as to the Rules of Play and the Laws of Badminton will be final.
12. Entries
 - 12.1. Entries are on-line only at <https://badminton.org.nz/event/new-zealand-under-17-championships-2023/> . (Phone, fax, text, e-mail or hand-written entries will not be accepted.)
 - 12.2. Entries close Wednesday, 4 October 2023 at 11:59pm. No late entries will be accepted.
 - 12.3. Only entries for which an entry fee has been paid can be accepted. Entry fees must be paid via PayPal at time of entering.
 - 12.4. A doubles entry is not confirmed until an entry and the entry fees are received from both players. (This excludes "partner required" entries).

12.5. Notification of withdrawal(s) with reason must be given immediately to the Event Director by email. If withdrawal arises after players have arrived at the venue, notification of withdrawal must be made in person to the Referee. A player may withdraw from individual events without being required to withdraw from all events unless the player cites COVID-19 as the reason for their withdrawal.

12.6. If a player withdraws after the closing date, the entry fee will not be refunded unless a medical certificate is submitted to the Event Director or Referee at the time of withdrawing. A \$15 administration fee will be deducted from all refunds. No refunds will be given for withdrawals once the draw is published.

12.7. There will be no replacements in singles. Replacements in doubles and mixed doubles events after the draw is published may be allowed only with the approval of the Referee. Replacement players can only be sought from players already entered in the tournament. Only one player in each pair can be replaced. If two players from two different pairs in the same event are put together, the placement of the new pair shall be at the position of the pair seeded in the highest seeding group. If none of the pairs are seeded, or seeded in the same seeding group, the position shall be drawn by lot between positions of the two original pairs.

12.8. A confirmed list of entries will be published on by Friday, 6 October 2023.

13. Seeding and Draw

13.1. The draw will be made on Monday, 9 October 2023 by Badminton New Zealand. The seeding's will be from the New Zealand Under 17 National Rankings respectively as of Wednesday 4 October. The Badminton New Zealand seeding policy will apply to this event.

13.2. Badminton New Zealand will make the draw in accordance with the Competition Rules of the BWF.

13.3. The draw will be published on Wednesday, 11 October 2023 and will be available on <https://badminton.org.nz/event/new-zealand-under-17-championships-2023/>

13.4. The schedule will be available by Monday, 16 October 2023.

14. General

14.1. All players enter at their own risk; no responsibility will be accepted for any injury received during the tournament.

14.2. Drug Testing may be conducted during the Tournament.

- 14.3. Matches may be called up to 10 minutes ahead of the stated time on the playing schedule.
- 14.4. Players will be entitled to a 20-minute rest period between Championships matches. For Division 2 and Division 3 matches, the organisers will endeavour to provide rest periods, but these are not guaranteed.
- 14.5. Competitors must abide by all decisions of the Event Director and Referee and comply with all the directions given.
- 14.6. The Referee may default players who are not available when required to play.
- 14.7. Trophies will be awarded to the Winner and Runner-Up in all championship events.

Submitting an entry represents your giving consent in accordance with the Privacy Act 1993 to the collection of the above details by Badminton New Zealand for the purpose of entering this tournament. Your right to access and correct any information is acknowledged.
