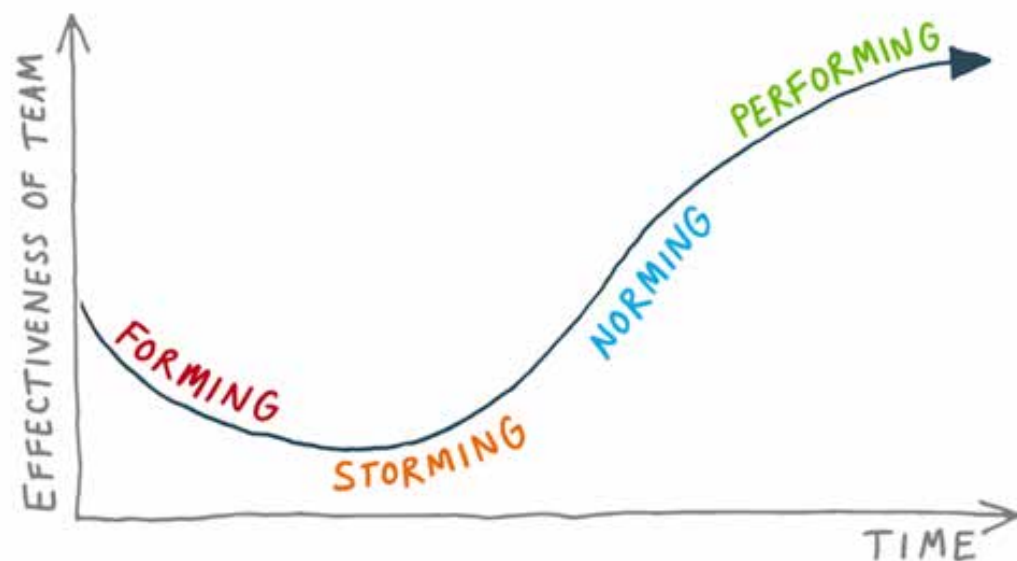






BOARD CHAIR & CHIEF EXECUTIVE

When thinking back about the year that was, the Tuckman Model of team development springs to mind. This looks something like the following:



The year started out in a storming fashion, with multiple discussions and debates about the place for major events in badminton in New Zealand. The need to choose a path ultimately saw New Zealand move away from hosting major events in the short to medium term, which was not a decision everyone agreed with. This decision was also a significant factor in some of the change that occurred around the Board table.

Closely aligned to the decisions around major events was concern about Badminton New Zealand's less than ideal financial result in 2022, which followed on from previous years of not great results. These financial concerns had to be turned around and also contributed to this sense of "storming" and general disquiet about the direction Badminton New Zealand was heading.

As the model above shows, when you are a storming phase of team development, the effectiveness of that team is typically at its lowest point. And it would be fair to say that, from our joint perspective, the early part of 2023 very much felt like a low point.

It is therefore very pleasing to report that the latter part of the year saw Badminton New Zealand move very much into a "norming" phase as we settled down and put in place some foundational pieces for the organisation. This work included:

- Post AGM, undertaking an extensive Board recruitment and appointment process, which concluded with the appointments of Simon Lin, Cheryl Christini, Alex Qi and Ravi Nyayapati to the Board. They joined Kerrin Harrison, who was elected at the AGM and Simone Naylor, who was also appointed at the AGM. This new Board has come together very quickly and is

working extremely well together. We have a great range of skills, experience and diversity and the Board Appointments Panel should feel proud of their efforts. A special thanks goes to Karen Blank from North Harbour who assisted on the Panel, along with our independent external consultant - Lindsay Corban, both of whom spent many hours working on behalf of the Board.

- Undertaking a reorganisation of the Badminton New Zealand team. Led by Stephen Nelson and Donna Trow, this change was completed successfully in November 2023. This restructure now means we have a team that is more aligned to our strategic plan, and in particular to improving the financial position of Badminton New Zealand, while at the same time endeavouring to expand and improve the delivery of our programmes and support to the wider badminton community.
- The Badminton New Zealand team have worked extremely well to adhere to their respective budgets and deliver a significantly improved financial result. To move from a \$41k loss position in 2022 to an almost break-even position in 2023 is a significant turnaround. This has taken hard work, but the staff have demonstrated to the Board that they have the finances under control, which is great position to be in and minimises fiscal risk. With the finances now well under control we can work towards achieving a surplus position in 2024 and to continue to grow from there.

So, in summary, we have a settled Board, a clear vision for the future (i.e. no major events for now), a much more stable financial position (and a plan to grow revenue) and a new structure for the team. These are all key elements as we now look to progress from being a "norming" organisation to one that is "performing".

However, there is also no doubt that there is still a likelihood of more storming in the future, especially as we continue to work with 24 Member Associations, all of whom have different views as to what is best for badminton. We saw this storming very much to the fore with the various debates around affiliation in 2023. Even though the Board reversed its initial decision in 2023 on affiliation change, we are confident that the final decision, made later in the year by the new Board, is indeed the more equitable decision. This will see for 2024 and 2025 Member Associations who have greater capability and greater opportunity pay relatively more than those who have less capability and opportunity. That seems very fair.

The diversity of needs, wants, opinions and general passion of our Member Associations is both an opportunity and a challenge for Badminton New Zealand as a whole. We are all part of Badminton New Zealand and our future success is likely to be determined by how well, or otherwise, we can all work together and pull in the same direction. We did pull together (or almost all together) on occasion in 2023, most notably when the organisation was wrestling with the "go" or "no go" decision around major events. Ultimately it was the consensus of the majority of Associations that determined the direction we would then head, and it was great to see this level of unity. The question for us all is, how do we do more of that and ideally in a more constructive way, rather than as a matter of last resort?

We have had some great support during 2023 with key funders such as Sport New Zealand, who have provided a significant amount of extra help, including financial/professional assistance,



often at short notice and when we were under pressure. That extra help was huge and got us through a stormy period relatively intact. We have also received financial assistance for various programmes from the likes of NZOC, Badminton Oceania and the BWF, as well as our many grant funders and other commercial partners. Thank you to all our partners for your input and help – it is hugely appreciated.

Also appreciated are the Board and the hardworking team at Badminton New Zealand. Thanks to the new Board for coming together so quickly and cohesively, which means we are well placed to deliver quality governance for Badminton New Zealand on behalf of our Member Associations. A massive thanks must also go to the team at Badminton New Zealand – they give it their all every day and do a huge amount of work, often with minimal levels of resource. We should all feel proud of this team and the work they do on behalf of us.

Finally, thanks must go to our Member Associations. You are Badminton New Zealand. Without our Associations and without your support we have very little. It is often said that no one owns a sport and that is certainly true of badminton. However, between all of us we do play a huge part in determining the way badminton is played in New Zealand. It is therefore up to all of us to do our very best to ensure that everyone who picks up a racquet has the best possible experience.

It feels as though Badminton New Zealand has built a more solid base for itself over the course of 2023. We are much clearer on what we will do, and what we will not do. We have moved from storming to the beginnings of norming. The challenge for 2024 will be how we now go about building on the foundation laid – we have the governance in place to do this and we also have the right people in the right roles. The magic will happen when we can bring everyone (or as many as possible of us) together and heading in the same direction. This is up to all of us, so as you read the rest of the 2023 Annual Report, we would encourage you to reflect on the year that has been and to think about what you and your Association can do differently to contribute to an even better badminton community in 2024 and beyond.



PROGRAMMES

COACH DEVELOPMENT

Shuttle Time:

After the first 6 months of 2023 had passed and having just over 16,000 participants, it was sadly looking like that by the end of the year, there would be approximately 25,000 participants - falling 5,000 short of our 2023 goal of 30,000. However, our Associations smashed that delivery figure! Achieving a total of 33,186 participants receiving Shuttle Time delivery. This was an increase of almost 10,000 participants from 2022.

Delivery of Shuttle Time courses has been a challenge during the year with only 3 Shuttle Time Teacher courses being delivered. Moving forward the aim in 2024 is to increase this delivery. Badminton New Zealand and the Associations need to collaborate to regularly upskill the Shuttle Time workforce as the ongoing development of this workforce is crucial to providing accessible, quality Shuttle Time experiences to Tamariki and Rangatahi.

A big thank you to everyone who has been involved with the delivery of Shuttle Time within schools, clubs and Associations and getting racquets in hands.

Hamilton Hit Out:

The Hamilton Hit was formed as a result of the Voice of the Participant survey findings. This event was developed as a racquet sports day where participants had the opportunity to have a go at Badminton, Tennis, Squash and Table Tennis. This project was co-designed and co-delivered by various Regional Sports Organisation's and National Sport Organisation's.

Information was collected from participants on the day to find out how they enjoyed the activities across all sports. 100% of those surveyed had fun, with the main reason being, "that they were able to play with their friends". They enjoyed having rallies and many of them wanted to know more about how they could further access badminton.

Coach Education – BWF Level 1:

2023 saw 11 coaches receive their BWF Level 1 Qualification. Congratulations to the following newly appointed BWF Level 1 coaches: Graham Berry, Chanmony Khieng, Caleb Young, Jack Dixon, Laarni Moreno, Alex Zhao, Ming Ghee Fong, Nikki Braniff-Jones, Anaiwan Ojala, Ryan Po, Alan Li. We look forward to seeing the progress and impact these coaches make within their Associations over the coming years.

Association Coach Development:

It was great to get out and about in the regions and meet many coaches doing great things to make badminton happen. Below is a summary of coaching activities that were delivered upon in 2023;

Balance is Better and the Role of the Coach - A webinar for Association Junior Team Championship Coaches was held prior to the national event focusing on: providing tips and tricks on building



team culture, team selections (how to include all players – and therefore optimise player experience) and coaches understanding players and the pressures they have on them and allowing them to play multiple sports.

New Zealand Junior Team Champs – whilst attending the 2023 NZJTC, many connections were made with our grassroots coaches. Conversations were had in order to gain an understanding of the environment they are coaching in, the challenges they are facing and listening to what upskilling they would like see developed. Off the back of these conversations, the Suzuki Coach Development Roadshow was formed and delivered upon.

Tier 2 Coaching Programme - Badminton New Zealand, through previous Regional Coach and Player Development Camps, identified and invited coaches to attend a Tier 2 Coach Development Programme. The coaches who were identified were introduced to themes and concepts that were being delivered to the National Girls Development Group and the National U15 & U19 Squads. They were then required to develop a plan, and deliver upon their plan whilst receiving mentoring from the Lead New Zealand Age Group Coaches – Tracey Hallam and Rikke Olsen Siegemund. The coaches were then charged with the task of taking their learnings back to their Association's to further develop their coaches.

BALANCE IS BETTER

Event Changes:

2023 saw significant changes to the events system with regards to Balance is Better, to ensure quality experiences for all participants. The following event changes were put in place and are now seen as common practice heading into the 2024 season;

Season Length – Under 13 and Under 15 Sanctioned and National Events must be held between April and October. This change reduced the length of the season for young players, thereby increasing the potential for them to participate in both a summer and winter sport.

Age Restrictions – U13, U15, U17 and U19 Sanctioned Events now have a four-year participation window, i.e. players must be turning either 9, 10, 11 or 12 to participate in Under 13 events. Senior events (including Internationals) are now restricted to players turning 15 or older. National events have the same restrictions except for Under 13's in which they must be turning 10, 11 or 12 (a three-year participation window).



Exemption Process - Badminton New Zealand now has an exemption process in place so that Associations can apply in exceptional circumstances for a player to compete above their eligible age.

National Rankings - U13's rankings are not visible on any electronic platforms. However, it is still used in the background as a tool for seeding to occur at tournaments to ensure a quality experience is delivered.

Balance is Better Champion:

In 2023 Badminton New Zealand recruited Jack Wang as Badminton New Zealand's Balance is Better Champion. Jack's role was to speak about the value of sport in his life and to raise awareness of Balance is Better. From this appointment, the Balance is Better Champion Mini-Series were produced. The mini-series features Jack talking to us about his badminton journey and supporters, across four short clips. The videos are accessible either directly through the Badminton New Zealand website, or BNZ Youtube playlist.



Balance is Better Advisory Group:

Thank you to all members of the Advisory Group for your expertise and guidance. Badminton New Zealand appreciates the robust conversations and collaborative approach in which this group operates to ensure a quality sporting experience for all participants in all forms of badminton, from community to performance.

The opportunity included attending an U19 Player training camp in Thailand (Banthongyord Badminton School, Bangkok) followed by playing in the BAT YONEX Pathumthani Junior International Series 2023. Thank you to Badminton Oceania for providing this opportunity for these aspiring players.

Lastly, Badminton New Zealand would like to thank all the New Zealand Development and Performance Coaches for the commitment they have given to the programme. We are continually grateful for the quality programmes that they deliver.

PERFORMANCE

Our overall plan for 2023 was to get our junior and senior players international exposure. If we look at this goal compared to our numbers from last year then we have done well, as we have had nine senior players playing tournaments outside our region, where in 2022 we only had two players competing overseas.

We were also represented at the World Junior Cup in Spokane, where the team managed to finish 23 out of 39 countries. We also had another six junior players competing in tournaments in Europe or Thailand.

New Zealand had a large contingent of players competing at the Oceania Championships held at Auckland Badminton Association. Notable performances included:

- Abhinav Manota won the Men's singles and Edward Lau finished runner up. This was Abhinav's last international tournament.
- Shaunna Li won the Women's singles.

Additionally on the international scene we also had a smaller group of players competing in the Sydney & Bendigo International Tournaments.

Our training setup in 2023 was the same as previous years - five weekly morning sessions and match play at Waitakere on Friday evenings.



We started to work with individual plans in 2023, meaning if we had players going overseas, they would have their own plans, while players competing in Oceania and Bendigo/Sydney Internationals would have an overall plan as these have been the tournaments we have targeted over the past years as a bigger group.

We also supported two players with a Strength & Conditioning Programme, to see if the introduction of a focussed programme would add value to their training and performance. We will look to continue this into 2024 (presenter dependant).

We would like to acknowledge Tony Griffen and Bjorn Siegemund for stepping up and taking the lead at trainings while our Performance Manager was away on extended sick leave.

Our goal for 2024 is to get more players overseas and/or get individual players to play more international tournaments as there is no doubt in my mind that we need more international exposure, exposure, and exposure.

We also want to work with the players so they get a better understanding of the S&C area, such as warming up/down, agility and gym exercises that are badminton specific. We will also be introducing this to our U19 Squad players at our camps throughout the year.

DIVERSITY & INCLUSION

Asian Engagement:

Badminton New Zealand has created the Asian Engagement Project – a three phase plan to embed diversity and inclusion through the badminton community.

The Asian Engagement Plan aims to highlight areas outside of participation where Asian engagement can be improved. Our initial insights have shown participation is typically Asian-saturated, but significantly decreased within governance, leadership, and staff roles. This data

is consistent with the findings presented in Sport New Zealand's Diversity & Inclusion survey (2020) & Sport Waitakere's 'Barriers to Asian Participation of Formal Leadership in Community Sport' research (2021).

In 2023 the following project tasks were completed:

- A Project Plan developed.
- The website landing page is currently in development. The website landing page will contain all information, links, and update to the project's progress.
- Connection & feedback from the following ActivAsian groups (Harbour Sport, Sport Auckland, CLM) has occurred.
- Data collection is now complete.
- The next steps will be to share the insights through the website aiming to raise awareness amongst Associations and clubs as this is information that has not previously been collected or collated. It has the potential to spark discussion and inspire Associations to invest in their diverse communities or provide the opportunity for Associations to share their successes for positive engagement.

Para Badminton:

Some highlights from the 2023 Para Badminton programme included:

Para Badminton Development:

- Para Sport Collective – an initiative from PNZ to bring together Pre-HP athletes and coaches for connection and upskilling over a 12-18-month period. Carrie Wilson, Michelle Au & Marianne Loh were a part of the 2023 intake.
- Badminton Oceania Thailand training opportunity – a training week in Bangkok with the Thai Para National team, for athletes who have the potential to qualify for Paris 2024 or LA 2028. Jo Christie (Coach) & Carrie Wilson (Athlete) were in attendance.
- BWF Disability Coaching Module – "Module 13" of the BWF Level 1 Coaching course. This was delivered in NZ for the first time from 5-7th May in Cambridge. 12 coaches from across the country participated. This was a HUGE step in growing the capability and sustainability of the Para badminton programme in New Zealand.
- BNZ Para Badminton Player Development Camp – this was held alongside the Coaching module above; this camp was aimed at Para badminton players who were new on the pathway. For some, this was their first opportunity to train over consecutive days, with other athletes with a disability – learning skills specific to Para badminton. Thomas Slade, NZ Para badminton player was the Assistant Coach for this camp.
- Halberg Games (14-16th April) – This was delivered in conjunction with Counties Manukau Badminton staff. Badminton had two sessions – a Come & Try session, followed by a competitive session.
- Healthvision Festival of Disability Sport (29-30th April) – BNZ, BOP Badminton & Parafed BOP ran a number of badminton opportunities at the festival.
- PNZ Classification Contestable funding – BNZ was fortunate enough to have been identified as an eligible NSO for funding to support development of 1-2 technical classifiers.



Congratulations to Wayne Wu, Alicia Fong and Vic Kim for becoming qualified BWF Level 1 Classifiers. This is massive for our sport as this will enable more classification opportunities and knowledge to be shared throughout the country.

Oceania Para Badminton Championships Results:

There was an incredible medal haul for New Zealand at the Oceania Para Badminton Championships, with five Oceania titles from our team of six Para athletes!

Wojtek Czyz (WKO) also competed at several international tournaments to support his qualification in the Race to Paris. His best results were finishing runner up at the Uganda Para Badminton International (Level 3) and making the quarterfinals at the Japan Para Badminton International (Level 2) and, making the quarterfinals in both the Singles & SL3-SL4 Men's Doubles at the Fox's Indonesia Para Badminton International (Level 3).

Badminton New Zealand is thankful for the support from Aotearoa Gaming Trust, Paralympics New Zealand, Badminton Oceania and the Badminton World Federation to enable many of these New Zealand Para badminton opportunities.



EVENTS

There has been a challenging environment for delivering events over the past few years, with 2023 unfortunately beginning on the same trend. Severe weather across parts of the country damaged facilities and presented difficulties for travel. Once again, our team swung into action to move and reschedule events where possible to ensure minimal impact on the upcoming season.

Auckland Badminton stepped in at the last minute to host the Oceania Championships following the devastating flood damage to North Harbour just a week earlier. The New Zealand teams finished second to Australia in both the senior and junior competitions, while Kiwis Abhinav Manota and Shaunna Li took home individual titles.

The NZ Tour is continuing to prove successful, with a strong following of players attending the five qualifying events across the country before concluding the season with an intense finals series. We are beginning to see progress as well in the development of technical officials around New Zealand with the Tour events providing more opportunities for umpires and referees to be part of major events. A big thank you to the 16 Associations across New Zealand who delivered sanctioned events throughout the season, especially those who stepped-up to replace events that were impacted by North Harbour's closure. It was fantastic to see Nelson and Thames Valley hosting their first sanctioned events, and we look forward to supporting other Associations to deliver events to ensure that quality opportunities for players continue to be available nationwide.



We were delighted to celebrate the 40th anniversary of the New Zealand Junior Team Championships in Palmerston North this year, with a record 72 teams entered. We continue to enjoy a strong and supportive partnership with Badminton Manawatu and Sport Manawatu, and it was a pleasure to celebrate this achievement with them and many notable guests at a

special function. A special thank you to all the staff and volunteers who have been bringing teams to this event for many years.

It was also pleasing to see an increasing number of teams attending the New Zealand Secondary School Championships. Growing participation at school level is essential for the future of our sport and the increased entries reflects the effort put in by associations to deliver local school competitions and Shuttle Time sessions in school.

Over the year, Justine returned to study and to focus on her badminton career, and Will Boyden joined the team after working at Auckland Cricket over the summer.

A special thank you to each of our supporters this year, including Auckland Council, Porirua City Council, Sport Manawatu, Wellington City Council, Christchurch City Council, New Zealand Sport Collective, Yonex, Suzuki, Pub Charity and Sal's Pizza.

Finally, the biggest thank you to each of our referees, umpires, line judges and volunteers who assisted us throughout the year. Without each of you, we could not continue to deliver outstanding events for our community.



TECHNICAL OFFICIALS

The 2023 season saw the continuation of the new training and development approach for our technical officials. The online training has proven to be an attractive option for prospective umpires, where we continue to see a number of candidates across the country in attendance, particularly those that are outside of Auckland and major centres. Whilst this has been great for providing training opportunities, it has been challenging to certify candidates due to the limited number of formal/sanctioned events where practical assessments could take place.

After the big uptake of referee training in 2022, the technical official committee was pleased to complete practical assessments for a number of prospective referees, boosting our referee numbers. This will help ease the heavy workload borne by our long-serving referees. There is more work to be done in 2024 to provide assessment opportunities to those who completed their training in 2022 and needed more tournament experience before being ready for assessment. Finally, we would like to congratulate Lynne Nixey, Julie Carrel, Trish Gubb and Renee Cui on their appointments for the upcoming 2024 Paris Olympic and Paralympic Games. Furthermore, our heartfelt thanks to Trish, who has decided to step down from the committee after 11 years of service in her second stint on the committee.

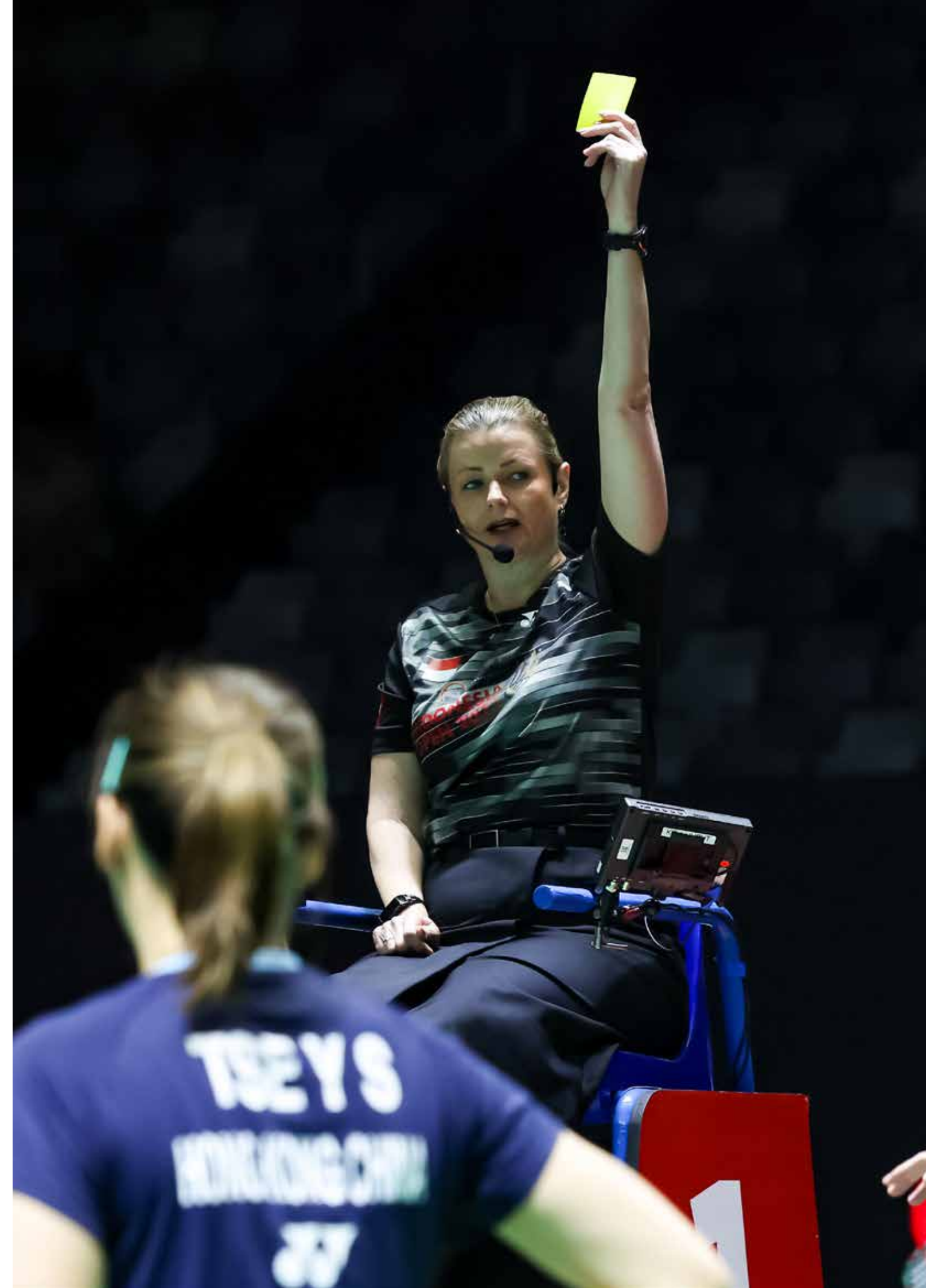

Notes to the Financial Statements

Badminton New Zealand Incorporated
For the year ended 31 December 2023

1. Reporting Entity

Badminton New Zealand Incorporated ('Badminton NZ') is incorporated under the Incorporated Societies Act 1908 and is subject to the provisions of the Act. The financial statements are a special purpose report which has been prepared in accordance with the accounting policies below.

These financial statements have not been prepared for external use. They are prepared for governance purposes only and should not be relied on for any other purpose.

2. Statement of Accounting Policies

The following accounting policies which materially affect the measurement of financial performance and financial position have been applied:

Measurement Base

These financial statements have been prepared on a historical cost basis.

Changes in Accounting Policies

There have been no changes in accounting policies. Policies have been applied on a consistent basis with those of the previous reporting period.

Revenue Recognition

Revenue is recognised on an accrual basis, and is measured at the fair value of consideration received or receivable.

Grants (including Sport New Zealand) and sponsorship are recognised when the conditions attached to the grants or sponsorship have been met, and have been utilised in accordance with these conditions. Until any such obligations have been met, any grants or sponsorship received in cash are shown as income in advance.

Membership Levies are recognised over the period of the membership (usually 12 months). Amounts received in advance for memberships relating to future periods are recognised as a liability until such time that period covering the membership occurs.

Entry Fees (including New Zealand Open), and Player Levies and Other Event Income, are recognised in the period in which the respective event or competition takes place. Amounts received in advance of the event are recognised as a liability until such time that the event or competition occurs.

Player Contributions for development programmes are recognised in the period in which the programme takes place. Any amounts received in advance of the development programme occurring are recognised as a liability until such time that the programme takes place.

Goods and Services received in kind are not recorded as revenue.

Accounts Receivable

Accounts receivable are stated at expected realisable value.

Inventories

Inventories are stated at the lower of cost, determined on a first-in-first-out basis, and net realisable value.



Fixed Assets

Fixed assets are stated at historical cost less any accumulated depreciation and impairment losses.

An item of fixed assets is derecognised upon disposal or when no further future economic benefits are expected from its use or disposal. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the year the asset is derecognised.

Depreciation

Fixed assets are depreciated at rates which are anticipated to write them off over their estimated useful life. The rates used are:

Holiday Pay Liability

Provision has been made for the Badminton NZ liability for annual leave. The annual leave has been calculated on an actual entitlement basis at current rates of pay. This equates to the cash amount necessary to settle the obligation as at balance date.

Income Tax

Badminton NZ is an amateur sports promoter and is exempt from income tax under section CW46 of the Income Tax Act 2007.

Goods and Services Tax

All amounts are stated exclusive of Goods and Services Tax (GST) except for accounts payable and accounts receivable which are stated inclusive of GST.

INDEPENDENT AUDITOR’S REPORT
TO THE BOARD OF BADMINTON NEW ZEALAND INCORPORATED

Opinion

We have audited the special purpose financial statements of Badminton New Zealand Incorporated (“the Society”), which comprise the balance sheet as at 31 December 2023, and the statement of profit or loss and statement of changes in equity for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

The special purpose financial statements have been prepared in accordance with the stated accounting policies, and are prepared solely for the Society’s Board, as a body. As a result, the special purpose financial statements may not be suitable for another purpose. Our report is intended solely for the Society and the Society’s Board, as a body, and should not be distributed to or used by parties other than the Society, or the Society’s Board. Our opinion is not modified in respect of this matter.

Board’s Responsibilities for the Financial Statements

The Board is responsible for the preparation of the special purpose financial statements in accordance with the accounting policies specified in Note 2 to the financial statements and for such internal control as the Board determines is necessary to enable the preparation of special purpose financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the special purpose financial statements, the Board is responsible for assessing the Society’s ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless the Board either intends to liquidate the Society or to cease operations, or has no realistic alternative but to do so.

GOVERNANCE REPORT

THE BOARD'S FOCUS

The Board focused on four identified priority areas for the organisation, these being:

1. Having the right people in the right roles.
2. Having a sustainable financial position.
3. Developing a member management system.
4. Reviewing how badminton does high performance.

This was in addition to the normal Board focus of identifying and mitigating risk, developing and adhering to the strategic plan, monitoring health, safety and wellbeing, and guiding the performance of the Chief Executive.

The Board workplan in 2023 also included the following:

- Continued use of Zoom for most Board meetings to help minimise costs.
- One face to face Board meeting was held, which allowed the connection of people.
- Making a final decision on the place of major events in the overall strategy.
- Making a final decision as to the affiliation fee model for 2023, 2024 and 2025.
- Supporting management with the restructure of roles within the organisation.
- Development of a Revenue Plan for Badminton New Zealand and eventual implementation in 2024.
- Undertaking a comprehensive review of insurances, which led to a change in broker and an improvement in insurance cover and management of risk.
- Began work on a review of performance programme (to be carried forward into 2024).
- Began work on a review of Badminton New Zealand Constitution to ensure compliance with new Incorporated Societies legislation (to be carried forward into 2024).
- Appointment and induction of several new Board Members as a result of resignations and retirements and subsequent elections and appointments.

BOARD COMPOSITION

The Board is comprised of four elected members (one of whom is President) and three appointed members. During the period:

- Susannah Leydon-Davis left the Board having given notice of her resignation at the end of 2022.
- Danny Chan retired from the Board having completed his maximum number of successive terms.
- Christina Yu chose not offer herself for election or appointment having completed her current term.
- Kerrin Harrison was elected at the AGM to fill one elected vacancy.
- Simone Naylor was appointed at the AGM to fill one appointed vacancy.

Following the AGM there were 1 elected and 2 appointed vacancies to be filled.

- Simon Lin was appointed to the Board.
- Nigel Skelt resigned from the Board, creating another elected vacancy.
- Cheryl Christini was appointed to the Board.
- Alex Qi was appointed to the Board until the next AGM to cover an elected vacancy.

2024 BOARD VACANCIES

A summary of upcoming Board vacancies is outlined below:

- The resignation of Ian Willans has created a vacancy for President to be filled in 2024.
- Alex Qi's short-term appointment (to fill vacant elected position) concludes at the 2024 AGM.
- Ravi Nyayapati's short-term appointment (to fill vacant elected position) concludes at the 2024 AGM.
- The remaining Board members, Kerrin Harrison (elected), Simone Naylor (appointed), Cheryl Christini (appointed) and Simon Lin (appointed) all have two years to run on their respective terms.

JEFF AND HEATHER ROBSON MEMORIAL BADMINTON TRUST

Badminton New Zealand has a very close relationship with this Charitable Trust, which was set up to support aspiring and talented New Zealand badminton players.

The Trust has been relatively inactive through the Covid years, but in 2023 undertook some activity and more is planned for the years ahead. The Badminton New Zealand Annual Report will now include an update on the Trust each year to provide greater visibility of its activities.

Originally known as the New Zealand Badminton Development Charitable Trust, it was the brainchild of Jeff and Heather Robson - two legends of New Zealand badminton. First established in 2010, the Trust has typically provided grants to upcoming New Zealand badminton players over the years.

In more recent times the administration of the Trust has been picked up by Badminton New Zealand, while at least one or two Board Members of Badminton New Zealand have also become Trustees to further solidify the close relationship between the two entities.
