Auckland U17 Open - Conditions of Entry 2025

GENERAL

- 1. It is expected that players will have read and agree with the 'Conditions of Entry' prior to submitting an entry.
- 2. Any player entering must be a member of, and in good standing with an Association affiliated to Badminton New Zealand or the Badminton World Federation.
- 3. The Rules of Play and scoring should be as per the Laws of Badminton outlined by the Badminton World Federation (overview of rules and scoring)
- 4. This tournament will be played using the Alternative Service Law 9.1.6.
 - The whole shuttle shall be below the server's waist at the instant of being hit by the server's racket. The waist shall be considered to be an imaginary line round the body, level with the lowest part of the server's bottom rib.
 - The shaft of the racket head of the server's racket at the instant of hitting the shuttle shall be pointing in a downward direction.
- 5. The Referee's decision on all questions as to the Rules of Play and the Laws of Badminton will be final.
- 6. YONEX AS20 or AS30 shuttles will be used.
- 7. The tournament director and/or Referee reserve the right to:
 - Cancel any event in which fewer than 8 entries are received, or if time does not permit a full competition to be played.
 - Cancel any plate event if time constraints require.
 - Change the scoring format for plates if time constraints are required.
 - Default a player who is not available to play at the scheduled time.
- 8. There will be one plate event in each event if numbers are sufficient and time permits. Plate entry is automatic for the losers of their first match. Players wishing to withdraw must advise the Tournament Director immediately after their first match loss. If a player defaults, withdraws or retires (does not complete) their first match, they are not eligible for the plate

SEEDINGS AND DRAW

- 1. The tournament will be seeded using the latest Badminton New Zealand National Rankings available at the date of entries closing.
- 2. The draw will be done on Tuesday 2 September 2025. The draw and the first day's schedule will be available on the Badminton New Zealand and Auckland Badminton websites on Wednesday 3 September 2025.

ENTRY DETAILS

- 1. Entry can only be made online and must be received no later than 23:59 on Wednesday 27 August 2025. Online entry can be made through www.aklbadminton.com and www.badminton.org.nz
- 2. Entries for doubles and mixed doubles will not be accepted unless full payment is received from both partners by the close of entries. This excludes 'partner required' entries. It is not the responsibility of Auckland Badminton to follow up entries from nominated un-entered partners.
- 3. Players withdrawing after entries have closed will not be eligible for a refund unless a medical certificate is submitted at the time of withdrawal. No refunds will be made for withdrawals after the tournament has commenced.
- 4. There will be no replacements in the singles events.
- 5. Replacements in doubles and mixed doubles events after the draw is published may be allowed only with the approval of the tournament director or referee. Replacement players can only be sought from players already entered in the tournament. Only one player in each pair in the draw can be substituted. If two players from two different pairs in the same event are put together, the replacement of the new pair shall





be at the position of the pair seeded in the highest seeding group. If none of the pairs are seeded, or seeded in the same seeding group, the position shall be drawn by lot between positions of the two original pairs.

- 6. A \$10 administration fee will be deducted from all refunds
- 7. There will be no fees refunded in the event if any of the plate events are cancelled.
- 8. A BNZ player levy of \$17.00 is compulsory and is included in the 'one event's entry fee
- 9. Players may withdraw from individual events without being required to withdraw from all events

PLAYER REQUIREMENTS

- 10. Matches dependent on entries will be scheduled to time and will be called up to 15 minutes prior to the scheduled time or will be scheduled 'followed by'
- 11. Players must be ready to play when called to court. If a player is not on court within 2 minutes after the match is called, the player will be defaulted.
- 12. Players must wear regulation badminton clothing as per the Badminton New Zealand Approved Clothing regulations.
- 13. All players must act as umpires or line judges when requested. Please check the websites prior to the session for player umpires (if needed).
- 14. Players compete at their own risk. No responsibility will be accepted for any injury received during this tournament.
- 15. Following one warning of misconduct, the referee shall have the authority to disqualify a player from further play if there is a repeat of misconduct.
- 16. U17 entry criteria players must be born between 2009 & 2012

COACHING Any person coaching during a match, including intervals, must meet the requirements of the Badminton New Zealand Accredited Coaches policy. Any person not meeting these criteria who refuses the request of the referee or tournament director to stop coaching may be referred to the Badminton New Zealand disciplinary panel.

PRIZES

A minimum of \$1,500.00 prize money will be offered subject to the event receiving a minimum of 80 unique entries into the tournament. Prize money may increase at the discretion of the Auckland Badminton Association. Prizegiving will be held at the completion of the event.

Semi-finalists will only be awarded prize money if there is a minimum of 8 entries (pairs for doubles) in the event. Players will be awarded this at the conclusion of the semi-finals.

Where prize money is not awarded due to a minimum entry not being reached, that prize money will be reallocated proportionately across all other events.
