<p><b>Regulations (Conditions of Play)</b></p>	<p>This tournament will be conducted in accordance with, but not limited to, the Badminton World Federation (BWF) Statutes and <a href="#">General Competition Regulations (GCRs)</a> and the <a href="#">Badminton Oceania Grade 3 Tournament Regulations</a>. In the event of any dispute, the decision of the Tournament Referee will be final.</p> <p>Clothing and advertising are in accordance with the BWF General Competition Regulations (sections 20-24). The name of the player is MANDATORY on the back of all the players' shirts. The country name is optional, however if it is on the shirt, it must comply with BWF regulations.</p> <p>Quarterfinals onwards GCR 21 regarding clothing colour will apply:</p> <ul style="list-style-type: none"> <li>• In Singles matches opposing players must wear significantly different coloured clothing</li> <li>• In doubles matches both players must wear the same colour clothing and opposing pairs must wear significantly different coloured clothing</li> </ul> <p>Players should ensure that they read these regulations and that their clothing complies with these regulations.</p>

## Entry Fees

All players are required to pay entry fees.

The entry fee for local players is NZD\$200.00

Member Associations will be invoiced on Wednesday 23 September with payment due by Monday 28 September 2026.

**Players will not be able to take to the court until their entry fee is paid.**

The Member Association that enters a player into the tournament is responsible for paying the entry fees for that player. Entry fees become due if a player is entered and has not been withdrawn by the Last Date to Withdraw without Penalty. Entry fees will not be refunded in the case of a withdrawal after the Last Date to Withdraw without Penalty.

Member Associations should contact BWF immediately if such notice is not received by Wednesday 2 September 2026 at 12:00 hrs BWF Headquarters time.

If no objection is received by BWF by Thursday 3 September 2026 at 23:59 hrs BWF Headquarters time, the entries shall be deemed to be correct. No complaints/objections will be entertained after this point.

## Withdrawals

Withdrawals will be managed according to BWF GCR 13 & 14 regulations. Withdrawals after **Monday 21 September 2026** shall automatically attract withdrawal fees as per BWF regulations.

Withdrawals until this date must be initiated through the online entry system by logging onto the tournament link used for lodging the entry.

<p><b>Presentation Ceremonies</b></p>	<p>All prize ceremonies will take place on <b>Sunday 4 October</b> immediately after the conclusion of each final. Trophies will be presented to all champions and finalists.</p> <p>No equipment, including rackets and flags, is allowed to be brought onto the podium. Clothing worn during the ceremony must be in accordance with the BWF GCR.</p>
<p><b>Medical Services</b></p>	<p>First aid and physiotherapist services will be available during the tournament.</p>
<p><b>Anti-Doping</b></p>	<p>Doping control in badminton, in accordance with <a href="#">BWF Anti-Doping Regulations</a>, is conducted out- of-competition and in-competition with the collection of urine and/or blood samples.</p> <p>Athletes are responsible for any substance found in their body. ## Badminton Integrity

Section 2.4 of the BWF Statutes ([Code on The Prevention of The Manipulation of Competitions](#)) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(s).
